Expression of Interest (EOI) for the Development of a Child Play Area at Shaheed Bhagat Singh International Airport

1. Introduction

SBSI Airport, Chandigarh is seeking Expressions of Interest (EOI) on behalf of Chairman, CHIAL from interested vendors for the development of indoor child play area within the airport premises. This area will cater to children travelling through the airport, providing a safe and engaging space for children to play while parents or guardians wait for flights.

The available pentagonal space (layout attached) for this project has been designated for play area inside the SHA.

2. Project Objective

The goal is to create a safe modern, interactive, and child-friendly environment that reflects the high standards of the airport and enhances the passenger experience.

The play area should be designed with the following considerations:

- Safety: Ensure compliance with all applicable safety standards and regulations.
- Durability: Use materials that can withstand high traffic and are easy to maintain.
- Aesthetic appeal: Create a visually attractive and pleasant environment.
- Interactive features: Incorporate engaging and educational play elements.
- Estimated cost of project 3 Lakh.(approx.)

3. Scope of Work

The scope of this project includes the following:

1. Design and Layout:

- Design a detailed layout with dimensions of each equipment for the play area, considering the attached layout to cater the requirement of kids upto 10 years of age.
- o Incorporation of following equipment is desirable-
 - PlayStation / play centre, (i/c 1 big spiral slide, 1 small slide, climbing structure and bridge)
 - See saw (senior)
 - Ride on
 - Swing with (min. Dimensions 66x67x45 inch)
 - Merry go round (min.dia 55 inch)
 - Artificial green grass carpet (50mm thick) all over floor space.
 - Walls/Glass cushioning upto a min. height of 3ft. on all walls.

Further vendors may incorporate extra playing equipment's for optimal utilization of available space and providing an enjoyable and stimulating environment for children.

2. Construction and Installation:

- Build and install the designed play area, ensuring adherence to all safety and regulatory requirements.
- o Ensure the use of non-toxic, durable, and child-friendly materials.

3. Compliance:

 Ensure the equipment supplied should have certifications under IS 6869, or ASTM F1487 or EN 1176.

4. Eligibility Criteria

Interested parties must meet the following criteria to submit an EOI:

 Proven experience (PO along with proof of payments/completion performance certificate) in designing and developing children's play areas, preferably in hightraffic public spaces such as airports or malls or schools or public park or residential society.

5. Submission Requirements

The EOI submission should include the following documents:

- 1. A brief company profile, including relevant experience in similar projects & clients.
- 2. Design concepts and ideas for the child play area, with sketches & layout along with dimensions.
- 3. A project timeline outlining key milestones and completion dates.
- 4. References from previous clients or project examples of similar work.

6. Submission Deadline

All EOIs must be submitted no later than 16.06.2025 before 11.00 am. Late submissions will not be considered.
