7 HOW TO APPLY: The Candidates who fulfill the eligibility criteria as on 13.06.2023 would be required to appear for Walk-in-interaction/ VC on the above date, time and venue. Further, they will keep with them all the original certificates/mark sheets/experience certificate/professional qualification certificates/ training certificates/Aadhar Card/ PAN Card/ other documents (if any) etc. **All the candidate must** fill the enclosed form and send the scanned copy of it along with all educational qualification documents, experience certificate documents and latest two months' salary slip(if employed) at jobs@chial.org. Candidate who has earlier appeared in the Interview for the post of Cargo Certified Security Screener **cannot apply again.**

8 GENERAL CONDITIONS:

- i. The short-listed eligible candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of three years and further extendable by a period of two years subject to their Medical Fitness, on job performance and meeting all eligibility conditions, prescribed for the position. The period of one year (for all positions) will be treated as probation period and on successful completion of probation period, the period of engagement will be considered for extension at the sole discretion of the Management of CHIAL.
- ii. The FTC will be renewable at the sole discretion of the management of CHIAL only subject to satisfactory performance.
- iii. The Contract could be terminated earlier at the discretion of the Management during the validity of the contract, and/or in the event of unsatisfactory performance.
- iv. The applicant must ensure that they fulfill all the eligibility criteria, as on 13/06/2023, and that the particulars furnished by him/her in the application are correct in all respects. At any stage of the Selection Process, if the particulars furnished by the applicants in the application or testimonials attached/provided are found to be incorrect / false, or not meeting with the eligibility criteria prescribed for the position, the candidature is liable to be rejected and, if engaged, engagement will be terminated, without giving any notice or reasons thereof.
- v. Any canvassing by or on behalf of the candidate or bringing political or other outside influence, with regard to their engagement / selection shall be considered as DISQUALIFICATION.
- vi. The decision of CHIAL Management regarding the eligibility criteria, acceptance or rejection of applications, mode of selection to the post etc. shall be final and binding on all the candidates. Merely fulfilling the minimum qualifications, experience and job requirement will not vest any right on candidates for being called for tests/selection process etc. No correspondence will be entertained from candidates found ineligible or not called for test/selection process.
- vii. CHIAL reserves the right to modify/ alter/ restrict/ enlarge/ cancel the engagement/ selections process (in part or full), if need so arises, without issuing any further notice or assigning any reason whatsoever. The decision of the CHIAL Management will be final and no appeal will be entertained in this regard.

- viii. CHIAL will not bear any liability on account of service bond/salary/leave salary pension contribution etc. if any, of previous employment of any candidate working in Central/ State Government/Autonomous Body/ Public Sector Undertaking.
- ix. CHIAL may increase or decrease in number of positions, without assigning any reasons whatsoever. The selected candidates can be deputed in any department of the Company and will have to perform all the screening and allied services including operation etc., as per the requirement of the company.
- x. Selected Candidates will have to bear the cost of the Pre-Engagement Medical Examination(s).
- xi. For the selection process/joining, no reimbursement w.r.t. TA/DA shall be made in this regard.
- xii. Character Certificate will be required at the time of joining, from previous organization and police verification shall be carried out as per BCAS Norms.
- xiii. On receipt of online application, the scrutiny/preliminary verification of filled in application/data shall be made by CHIAL, to ascertain the eligibility. In case the total eligible applications shall be equal to or higher than 2 times of the total positions than CHIAL shall shortlist the candidates on the basis of marks secured in Class XII examination.
- xiv. **The contract of selected candidates shall start from 23rd June 2023 itself with the last date of joining as 1st July 2023** after which the offer of engagement would be cancelled automatically. Candidates must prepare themselves in this regard.
- xv. **In the event the selected candidate desires to terminate the contractual appointment 90 days notice period is mandatory or payment of 3 months salary in lieu of the notice period.**
