The short-listed eligible candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of three years and further extendable by a period of two years subject to their Medical Fitness, on job performance and meeting all eligibility conditions, prescribed for the position. The period of one year (for all positions) will be treated as probation period and on successful completion of probation period, the period of engagement will be considered for extension at the sole discretion of the Management of CHIAL.
- ii. The FTC will be renewable at the sole discretion of the management of CHIAL only subject to satisfactory performance.
- iii. The Contract could be terminated earlier at the discretion of the Management during the validity of the contract, and/or in the event of unsatisfactory performance.
- iv. The applicant must ensure that they fulfill all the eligibility criteria, as on 23/06/2023, and that the particulars furnished by him/her in the application are correct in all respects. At any stage of the Selection Process, if the particulars furnished by the applicants in the application or testimonials attached/provided are found to be incorrect / false, or not meeting with the eligibility criteria prescribed for the position, the candidature is liable to be rejected and, if engaged, engagement will be terminated, without giving any notice or reasons thereof.
